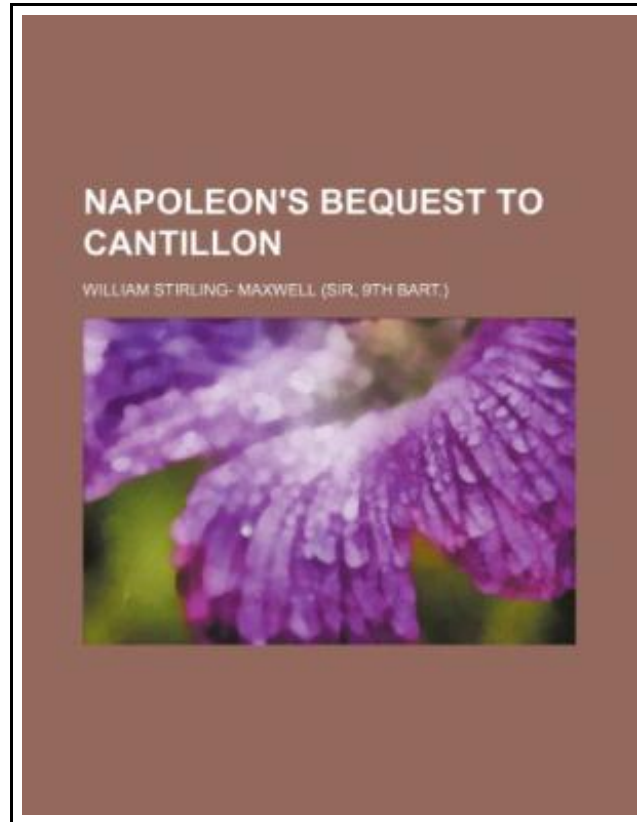

Not illustrated. 1858 Excerpt: .Towards the end of 1852, the Emperor of the French entered into negotiations with the British Government with a view to obtain possession of the will. The result of these negotiations, which passed through the hands of no less than three Secretaries of State for Foreign Affairs, was that Mr. Dyke, Queen s Advocate, on Thursday, 17th February, 1853, applied to Sir John Dodson, judge of the Prerogative Court, for delivery out of the registry of the will and codicils. He supported his application by a proxy of consent executed by the two surviving executors, Counts Montholon and Marchand, and by an affidavit by Lord John Russell, then Foreign Secretary, stating that the French Government had asked for the original will, and that Her Majesty s Government considered it advisable on grounds of public policy that the document should be delivered up. The learned judge, after examining various precedents and discussing the circumstances of the case, directed that the will, after a notarial copy had been made and a receipt taken, should be given over to the Secretary of State for the purpose of being delivered by him to the legal authorities of France<sup>8</sup>. The narrative of the removal of the will from London to Paris, as related in the *Moniteur*, not only contains some further information, but is a pleasing specimen of Imperial court newsmanship. France, says the official organ, on the 13th of April, 1853, has just been put in possession of an historical...
